ORDER

The following modifications/alterations are made in the Rules for Reservation and Occupation of Rest houses etc. issued vide G.O. (P)No.58/2013/PWD dated 17.07.2013.

(i) Judges of High Court, Deputy Speaker and those who are having Cabinet Rank in the State and Central Governments are also included among the non-payee group in rule 5.2.1.

(ii). Under Item (d) in Annexure V, in addition to Cabinet Ministers of the State, Deputy Minister of the Union, Leader of Opposition, all those who are having Cabinet Rank in the State and Central Government are also included.

(iii) In Rule 5.10.1, Chairman and Members of KPSC, District Panchayat Presidents and Corporation Mayors are also included for concession same as of Grade I Government Officers.

(iv) The Chairman of the PSUs/Corporations and retired Chairman & Members of PSC are eligible for accommodation at a concessional room rent of 50% per day.

(v) In Rule 5.10.2, Members of Kerala Public Service Commission is deleted. Former MPs and former MLAs are eligible for accommodation at a concessional room rent of Rs.100/- per day.

The Government Order read as 1<sup>st</sup> paper above stands modified to the above extent.
