ORDER

As per Government Order read above, sanction was accorded to M/s. Steel Industriáls Kerala Limited (SILK), to collect metallic scrap arising from the premises of Government Departments, Public Sector Undertakings and Quasi Government agencies, for consumption or for conversion subject to the condition that annual rate contract is fixed on the basis of mutual negotiation instead of market price.

As per the D.O.letter read above, Additional Secretary to Government, Finance Inspection (NT-F) Department has informed that some Government institutions are selling scrap materials to certain Public Sector Undertakings at upset price. Those Public Sector Undertakings sell them at a higher rate in the market. Thereby, this helps the Public Sector Undertakings indulging in the practice, to make undue profits to private persons/firms etc. Finance Inspection (NT-F) Department has hence recommended to issue order/circular directing that all scraps accumulated in Government Offices should be sold through open tender only.

Government have examined the matter in detail and are pleased to order that all

scraps accumulated at Government offices henceforth should be sold through open tender only, to avoid loss to public exchequer.

All Government Departments, Public Sector Undertakings and Quasi Government agencies should strictly adhere to the above instructions.
